

2020 Membership Fees and Guidelines

-All rates are based on the number of people in your family. A primary member must be at least 18 years old and in good standing with POSC.

-Any person over 21, who is not the spouse of a primary member, must join separately as the primary member.

-Any person under 18 must join with a primary member. Children under the age of 2 as of May 23, 2020 are free.

-If you have more than 6 members in your family, add \$40 for each additional member.

-**Childcare providers** can join for \$75, but should attend the pool only while the child is in their care.

-**Senior Citizens** (Age 62 and older) receive a 10% discount on their membership.

ID cards will be available at the pool entrance beginning Opening Day, Saturday May 23rd. Cards must always be presented for entrance into the pool, and all members and guests **MUST** sign in each time they visit the pool. **For Additional information, contact Lori Cardone at (717) 757-1021 or jcardone500@comcast.net.**

Guest fee is \$8.00 per visit, or \$4.00 after 5 p.m. All fees should be paid to the lifeguard on duty. There is a 6-visit limit per person per season for non-members. All guests **MUST** be accompanied by a POSC member.

Rules are posted at the pool. **ALCHOL IS FORBIDDEN AT ANYTIME.** Anyone not abiding by the rules set forth by POSC will be warned and/or asked to leave. **Any child under 13 years of age must be supervised by an individual 16 years of age or older. As recommended by the American Red Cross, children 6 years of age and under must be supervised by an adult pool-side.**
